### WHAT IS THIS PRODUCT?

#### Type:

UCITS. The Class AA € Accumulating has been selected as being representative of Class AA € Distributing, and as such separate PRIIP has not been prepared for this share class.

#### Term:

This product is not subject to any fixed term.

#### Objectives:

To provide investors with long-term capital growth by investing, on a global basis, primarily in equities of companies that meet the social, environmental and ethical criteria as described in the Investment Policies

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator
