WHAT IS THIS PRODUCT?

Type

UCITS. The Class AA (EUR) Accumulating has been selected as being representative of Class AA (EUR) Distributing, and as such separate PRIIP has not been prepared for this share class.

Term:

This product is not subject to any fixed term.

Objectives:

To achieve capital appreciation by investing in a portfolio of large capitalisation equities.

Intended Retail Investor:

A typical investor will be seeking to achieve a return on their investment in the medium to long term.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?
