
Objectives:

To seek returns with a balance between capital growth and income generation with lower volatility than a typical long term growth strategy.

Intended Retail Investor:

Investors who have a moderate approach to risk, with a balance between lower volatility and higher volatility assets.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 7 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

Risk indicator
