WHAT IS THIS PRODUCT?

This product is not subject to any fixed term.

Objectives:

The investment objective of the Davy Private Equity Strategies Fund 1 is to generate long term capital growth by investing primarily in a range of private equity type investments. J&E Davy asInvestment Manager will principally aim to achieve private equity exposure by investing in a diversified portfolio of private equity Investment Funds giving due consideration to the quality of the underlying fund's investment management team, their strong long term track record and their diverse global investment activities. Such Investment Funds may include large buyout funds, venture capital funds, real estate funds, mezzanine funds and special situation funds. While the Investment Manager will generally seek exposure to private equity Investment Funds, the Investment Manager retains the discretion to vary the asset allocation due to market conditions or the availability of appropriate investment opportunities.

Intended Retail Investor:

The Product is targeted at Eligible Counterparties, Professional Clients and Retails Clients (only where retail clients meet the Irish Qualifying Investor criteria). The investor's objective for this investment should be aligned with that of the Product as outlined above.
