### WHAT IS THIS PRODUCT?

#### Type:

UCITS. The Class A Accumulating has been selected as being representative of Class A Distributing, and as such separate PRIIP has not been prepared for this share class.

#### Term:

This product is not subject to any fixed term.

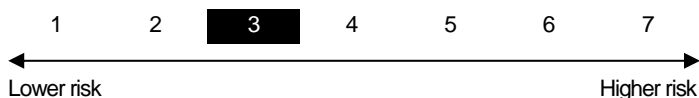
#### Objectives:

The investment objective of the Fund is to seek to provide steady capital appreciation by investing in a diversified portfolio of both UK and overseas investments.

#### Intended Retail Investor:

Investors who prioritise reduced risk. It follows a strategy which aims for lower to medium volatility, but which could produce lower returns over the medium to long term.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

#### Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.

**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

### Costs over Time
