### WHAT IS THIS PRODUCT?

#### Type:

UCITS investment company.

#### Term:

This product is not subject to any fixed term. However, the Board of Davy Fund plc, at their discretion, can redeem all the Shares of the Fund under the circumstances set out in the Redemptions section of the Prospectus.

#### Objectives:

The investment objective of the Fund is to achieve capital appreciation over the long term through a global investment approach.

#### Intended Retail Investor:

Investors who have longer term investment objectives, and who are willing to accept a higher degree of volatility in pursuit of higher returns over this period. Investors must be able to bear the total loss of the invested amount.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### Risk indicator

### Costs over Time
