### WHAT IS THIS PRODUCT?

#### Type:

UCITS investment company

#### Term:

This product is not subject to any fixed term. However, the Board of Davy Fund plc, at their discretion, can redeem all the Shares of the Fund under the circumstances set out in the Redemptions section of the Prospectus.

#### Objectives:

The investment objective of the Fund is to seek to achieve a lower volatility than equity markets over the long term whilst seeking to achieve positive returns. This will be achieved by predominantly taking positions in a variety of CIS that employ specific investment strategies. The Fund is actively managed in terms of selection of investments. Income is not paid out and is rolled up (accumulated) into the value of your investment. You may buy and sell your investment on each business day.

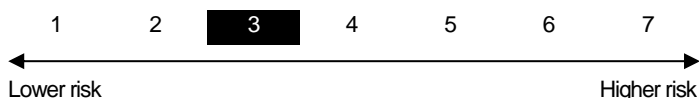
#### Intended Retail Investor:

A typical investor will be seeking to achieve exposure to fixed income, adjustable rate securities or Deposits and a return on its investment in the short to medium term. Investors must be able to bear the total loss of the invested amount.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



#### Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

**We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.**

**The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.**

**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. ### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
