## IQ EQ Defensive Equity Income Fund

Class H Sterling distributing shares of IQ EQ Defensive Equity Income Fund ("the Fund") a sub fund of the Davy Funds Plc (the "Company"). (ISIN IE00BD8R7M41)  
The Fund is managed by IQ EQ Fund Management (Ireland) Limited (the "Manager").

## Objectives and Investment Policy

### Investment Objective:

The Fund's investment objective is to achieve stable long-term growth in both capital and income by investing directly and/or indirectly (via financial derivative instruments ("FDIs") and exchange traded funds ("ETFs")) in a diversified portfolio of global equity securities. There is no guarantee or assurance that the investment objective of the Fund will actually be achieved.

### Investment Policy:

The Fund Manager invests in large global companies which it believes likely to have reasonable dividend yields and that are also likely to increase their dividend payouts each year. Each quarter the Fund Manager sells call options on some stocks within the Fund. A call option on a stock gives the buyer the right (but not the obligation) to purchase that stock at a specified price within a set time period. The seller of the call option (the Fund) receives a sum of money called a premium. The Fund then uses this premium each quarter to buy put options on some of the leading equity indices. A put option on an equity index gives the buyer the right (but not the obligation) to sell that index at a specified price on a certain date. The Fund expects this strategy to reduce the risk of significant losses for investors in the Fund.

The Fund is actively managed and is not managed in reference to a benchmark, however, the Fund's performance may be measured against the MSCI World Index. The Fund does not operate any form of target to outperform a benchmark index.

### Other Information:

- The Fund may use FDIs for efficient portfolio management and currency hedging purposes. Such techniques and instruments include options and forwards.
- You can buy, exchange and sell shares in the Fund on a daily basis on any business day in Dublin.
- Subject to net income being available for distribution, the Directors intend to declare dividends on the distribution date, which shall usually be 31 March and 30 September in each year (the "Distribution Date"), and such dividends will be paid on or before the 14<sup>th</sup> Business Day following the Distribution Date.
- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

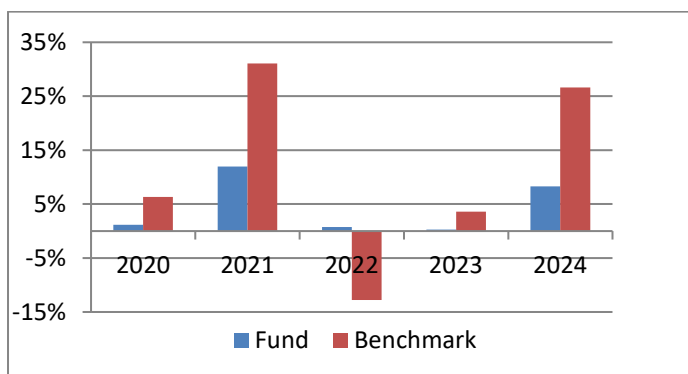
