The Fund is managed by IQ EQ Fund Management (Ireland) Limited (the "Manager")

Objectives and Investment Policy

The investment objective of the Fund is to provide capital growth over the medium to long term.

The Fund intends to achieve its investment objective by investing in equities, equity related securities, government and investment grade bonds and indirectly in these securities through Financial Derivative Instruments (FDI) subject to the leverage limits outlined in the Fund Prospectus.

The equities and equity related securities will primarily comprise of UK equities listed and traded on a recognised exchange. Examples of equity related securities may include equity market indices such as the FTSE 100, S&P 500, Eurostoxx 50, Russell 2000, Swiss Market Index, Topix and Nikkei 225 through which the Fund will gain exposure to all of the stock in that particular index.

At the beginning of the selection process, the Investment Manager considers which potential Indices, equities, or Bonds may benefit the Fund, having regard to the Fund's investment objective and policy as well as economic and market conditions. The Fund's equity exposure will mainly be gained through a series of auto-call options (i.e., a type of call option) which will be linked to certain equities, baskets of equities or equity market indices and will have multiple potential maturity dates.

The Dealing Day is Every Business Day and such additional day or days as the Directors may determine and notify in advance to Shareholders.

The Class B GBP Shares (the "share class") does not pay a dividend. The Fund is suitable for investors who are seeking capital growth over a medium to long term horizon but who are willing to tolerate medium to high risks due to the potentially volatile nature of the investments.

It is recommended that investors retain their investment in the Fund for a minimum of 5 years.

The Fund is actively managed, and the Investment Manager has the discretion to select the Fund's investments. The Fund is not managed with reference to a benchmark. The performance of the Fund can be assessed, however, by considering whether the objective is achieved, i.e. whether there has been capital growth over the medium to long term.
