## Objectives and Investment Policy

The investment policy of the Fund is to provide capital appreciation and income over the medium term through an actively managed, diversified portfolio of equities of companies predominantly based in the United States.

The Fund aims to outperform the S&P 500 index which it uses as its benchmark (the "Benchmark"), over a rolling three year time horizon.

The Fund will invest at least 80% of its assets in equities and equity like securities such as preferred stock or American Depository Receipts (ADRs) listed in the United States.

The investment strategy of the Fund will be based on a fundamental value-oriented stock picking methodology that targets stocks that are trading at discounts to their intrinsic worth.

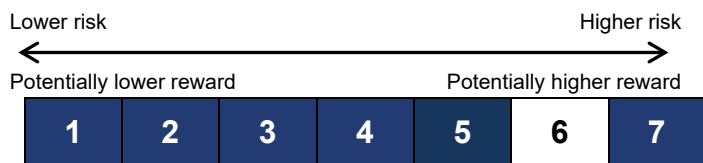
The Fund's investment strategy is size agnostic and there will be a mix of capitalisation sizes of stocks, however the Fund will typically skew towards larger cap stocks.

This share class pays a dividend such that substantially all of the net income relating to this share class shall be distributed on a semi-annual basis. Such dividends shall be paid to Shareholders in accordance with the terms of the Prospectus as set out in the section entitled "Dividend Policy".

The Fund is suitable for investors who are willing to tolerate medium to high risks and who are seeking a portfolio which has a minimum of 3 year term.

The Fund is actively managed in reference to the Benchmark as its performance is compared to the Benchmark in marketing materials and the Fund's performance is measured against the Benchmark for performance comparison purposes only. Investments in the portfolio are not specifically selected from the constituents of the Benchmark, hence the Fund's investment policy is in no way constrained and the degree of deviation from the Benchmark may be significant..

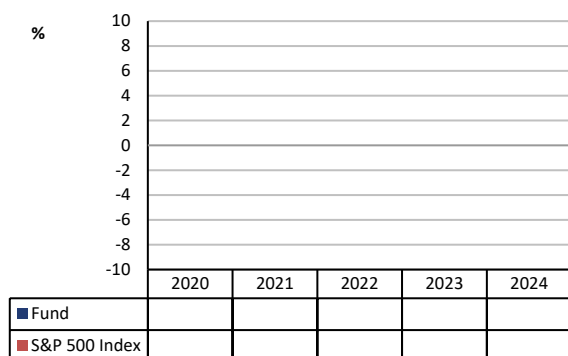
