### WHAT IS THIS PRODUCT?

#### Type:

UCITS investment company.

#### Term:

This product is not subject to any fixed term. However, the Board of Davy Fund plc, at their discretion, can redeem all the Shares of the Fund under the circumstances set out in the Redemptions section of the Prospectus.

#### Objectives:

The investment objective of the Fund is to provide capital growth while targeting a relatively low level of portfolio volatility of between 50% to 70% of global equity market volatility over rolling three-year periods. The Fund intends to achieve its investment objective by gaining exposure primarily to a globally diversified portfolio of equities, bonds and alternative assets. The Fund is actively managed in terms of selection of investments. Income is not paid out and is rolled up (accumulated) into the value of your investment. You may buy and sell your investment on each business day.

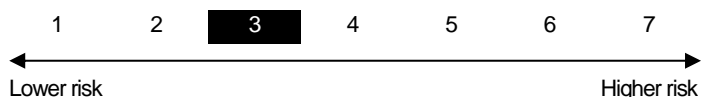
#### Intended Retail Investor:

A typical investor will be seeking to achieve exposure to fixed income, adjustable rate securities or Deposits and a return on its investment in the short to medium term. Investors must be able to bear the total loss of the invested amount.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

#### Risk indicator

**We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.**

**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

### Costs over Time

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

- EUR 10 000 is invested.
