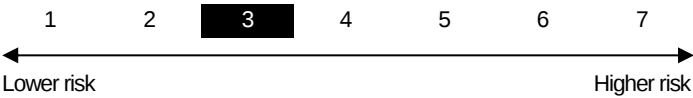
Objectives:

The objective of The Managed Fund is to seek to achieve capital appreciation. The objective will be achieved by investing in a range of assets which will be primarily equities, investment grade bonds, property and cash. IQ EQ Fund Management (Ireland) Limited as Investment Manager will vary the proportion of The Managed Fund invested in each asset class in line with its views on the relative growth potential of each sector and consistent with its policy of maintaining a diversified portfolio.

Intended Retail Investor:

The Product is targeted at investors who have subscribed for Units via a distribution agreement with an affiliate of IQ EQ Fund Management (Ireland) Limited. The investor's objective for this investment should be aligned with that of the Product as outlined above.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 1 year. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Risk indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. This product does not include any protection from future market performance so you could lose some or all of your investment.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

The recommended holding period for the Fund is 1 Year. Repurchase requests can be made at each valuation point. In certain circumstances, liquidity may be limited where redemptions exceed 10% of the Net Asset Value, and an anti-dilution levy may be applied upon redemption.
