A. Trustee and Security Trustee

As Trustee and Security Trustee, we provide independent oversight, governance and protection of investor rights across securitisation and structured finance transactions. Our role includes the following responsibilities:

- Acting as Issuer/Note Trustee, representing investors and safeguarding their interests
- Maintaining and reconciling the trust bank accounts
- Managing the payment of expenses and distributions to noteholders and beneficiaries
- Holding an equitable assignment over the loan assets to secure trust obligations
- Providing independent oversight of trust structures and collateral assets
- Enforcing security interests and ensuring compliance with trust documentation
- Maintaining a register of security via PPSR registrations and associated filings
- Ensuring the safekeeping of all security documentation throughout the transaction lifecycle
- Managing amendments, releases and ongoing changes to security documentation as required
- Participating in calls and meetings to provide support on security and governance matters
- Taking enforcement action when directed by the secured parties
