The Fund is managed by IQ EQ Fund Management (Ireland) Limited (the "Manager")

Objectives and Investment Policy

The Fund's objective is to generate long-term returns. There is no guarantee or assurance that the investment objective of the Fund will actually be achieved.

The Fund aims to achieve this objective by investing primarily in equity and equity-linked securities of issuers (such as debentures, notes or preferred stock) that are traded on Markets or OTC, in both developed and emerging markets.

The Fund may invest in non-US issuers through depositary receipts and participatory notes.

The Fund may also invest in stocks purchased in underwritten initial public offerings of equity securities.

The Investment Manager generally seeks diversification rather than concentration by industry, country or currency when stocks are similarly valued.

The Fund may invest in pooled real estate investment vehicles such as real estate investment trusts.

For short-term cash management and defensive investment purposes, the Fund may invest in cash and/or investment grade money market instruments with maturities up to one year.

The Fund is managed in reference to MSCI All Country World Index (Net) USD (the "Benchmark"). The Fund's performance is compared to the Benchmark in the marketing materials. The Benchmark represents the best approximation of the universe of securities in which the Fund may invest. The Fund's investment policy is not constrained and the degree of deviation from the Benchmark may be significant.

Class A USD\$ Shares (the "share class") do not pay a dividend. Any income arising is retained in the Fund and reflected in the value of the share class.


Shares in the Fund can be bought and sold on any business day in Ireland.

The Investment Manager has identified the Fund as an Article 8 product for the purposes of Regulation (EU) 2019/2088.

Recommendation: The Fund may not be appropriate for short-term investment. The Fund is suitable for investors seeking capital growth through direct and/or indirect investment in a diversified portfolio of global equities who are prepared to accept a high degree of volatility.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.



*The Directors may charge an Anti-Dilution Levy of up to 0.4% which will be calculated to cover the costs of acquiring or selling investments as a result of net subscriptions or redemptions on any Dealing Day where the Directors believe it is necessary to prevent an adverse effect on the value of the assets of the Fund. The level of the Anti-Dilution Levy may vary but shall not exceed 0.4% in respect of subscriptions and redemptions.

The ongoing charges are based on the expense ratio, as stated in the Fund Supplement, which have been reviewed as of 30 April 2025. Ongoing charges exclude transaction costs and one-off charges. Ongoing charges may vary from year to year and have the potential to be lower.

Classes A, B, C, D, E, F, G, H, K, PA, PA ADV and WA Shares do not pay a dividend. However, Class A2, Class B2, Class PD, Class PD ADV and Class W2 Shares may pay a dividend on a semi-annual basis where substantially all net income relating to Class A2, Class B2, Class PD and Class PD ADV Shares shall be distributed.
